<p>*Foundation Board terms are for three years and are attributed to an <u>individual</u>, not to the country or representative body (per Swiss Authority regulations concerning Foundations).</p> <p>Until 2021, WADA was registering members based on their country or representative body, and when there was a member change, the new member would only fulfill the remainder of the previous member's three year term in effect. This was incorrect.</p> <p>Three year terms now start on the day WADA is advised of a change in membership, which may not always take effect at the beginning of a calendar year as was previously the case. Given this shift in practice, some terms still appear to be aligned with the calendar year (where there has been no member change prior to the three year term ending), whereas members who have changed prior to the three year term ending will have a different term start and end date, depending on when they were appointed during the year.</p>
