<sup>1</sup> The Athlete Council is composed of three groups of athlete representatives. Group 1 corresponds to five athletes appointed by the International Olympic Committee's (IOC's) and International Paralympic Committee's (IPC's) Athletes' Commissions (ACs). Group 2 corresponds to eight athletes elected by the ACs of International Federations. Group 3 corresponds to seven other athletes selected by an appointment panel made up by a majority of athletes, to fill skills and diversity gaps.

<sup>2</sup> The initial term of Group 1 members was one year because of the staggered rotation of the inaugural WADA Athlete Council members. The representatives of the IOC AC are expected to be renewed, pending confirmation, and the representative of the IPC AC has been confirmed for a further term of three years.

<sup>3</sup> Following its selection process to find the [next athlete member of the Compliance Review Committee \(CRC\)](#), WADA's Athlete Council approved the candidate recommended by a selection panel formed of members of the Athlete Council and the WADA Nominations Committee. The WADA Executive Committee (ExCo) endorsed the recommendation to appoint Dr. Renae Domaschenz at its 16 November 2023 meeting. The Athlete on the CRC cannot be a member of the Athlete Council itself.

<sup>4</sup> Given Mr. Sal Perna has advised WADA he is not in a position to continue on the WADA Independent Ethics Board (IEB) for a further term, a call for interest will shortly be issued by WADA to find a new independent member of the IEB, who will be identified and vetted by the Nominations Committee. They will make a recommendation to the WADA Foundation Board (Board) via a circulatory vote in due course.

<sup>5</sup> At its [17 November 2023 meeting](#), the Board agreed that Dr. Rožle Prezelj be automatically approved for an additional three-year term further to the recommendation of the Nominations Committee.

<sup>7</sup> The WADA Risk and Audit Committee is responsible for appointing their Chair from between the two external experts and a decision will be taken in this regard at their first virtual meeting in December 2023. The exact term end of the two experts will therefore be determined once the decision is made, as the Chair will have a three-year term and the Vice-Chair a two-year term (as approved by the ExCo at its [22 September 2023 meeting](#)).
