

## Technical Document for Sport Specific Analysis (TDSSA)

### Summary of Major Changes from TDSSA 10.0 to TDSSA 11.0

- a) In line with the revised Technical Document on Dried Blood Spots ([TD2026DBS](#)) approved by the WADA Executive Committee on 11 September 2025, the TDSSA v11.0 clarifies that DBS samples that are analyzed for the 'small peptides' or 'ERAs' menu will be included in the calculations for the GHRFs and ERAs MLAs respectively, when collected both in isolation or together with any other type of sample (urine and/or blood).
- b) Amendments have been made to the list of sports/disciplines following requests by a number of International Federations (IBSA, IWWF, UIM and WBSC) to add new disciplines and/or to revise existing ones. In addition, since World Boxing recently became a member the Association of IOC Recognised International Sports Federations (ARISF) and an associate member of the Association of Summer Olympic International Sports Federations (ASOIF), the relevant sport/discipline has been added in Appendix 1 of the TDSSA v11.0. The full list of changes is outlined in Appendix 1 and 3 below.

- c) The TDSSA v11.0 also clarifies that all relevant MLAs apply to any sport and/or discipline that has a 'physical' esports version of its sport and/or discipline e.g. cycling on a stationary bike in a virtual digital environment.
