1. Introduction

1.1 Digital Education and Learning Strategy (DELS)

- The World Anti-Doping Agency (WADA) has identified digital learning as a strategic priority in line with its “Grow Impact” and “Be Athlete Centered” goals from the 2020-2024 strategic plan. To maximize the impact of WADA’s investment in Digital Education and Learning, a [Digital Education and Learning Strategy \(DELS\)](#) was developed by the Education team and included in the Education Committee Chair’s report to the Executive Committee in May 2023. The purpose of the strategy is to enable Anti-Doping Organizations (ADOs) to educate their target audiences, such as athletes, coaches, and parents, and to continue to support the technical development of practitioners through WADA’s Global Learning and Development Framework (GLDF) and its Code Implementation Support Program (CISP).
- The strategy contains the vision for learning enabled by technology and serves as the foundation for the direction of WADA’s Learning Management System (LMS) platform known as Anti-Doping Education and Learning (ADEL), with the goal of hosting accessible educational opportunities for athletes, athlete support personnel, administrators, and professionals working in the anti-doping industry, as well as enabling ADOs to fulfill their responsibilities under the World Anti-Doping Code (Code) and the International Standard for Education (ISE).
- It is essential to continue monitoring developments in accordance with the DELS so that progress can be evaluated, and challenges, opportunities, and trends can be identified. This DELS annual report serves to provide an update on the third year of implementation of DELS, as well as give an overview of the progress of WADA’s digital education and learning offerings since the introduction of ADEL in 2021.

1.2 Overview of ADEL

- On 6 January 2021, WADA launched a new and improved ADEL platform which was a complete overhaul of WADA’s initial LMS launched in 2018.
- ADEL is the centralized platform primarily offering educational solutions for ADOs to complement or use in their education programs or to extend the reach of their existing education programs. Education solutions available on ADEL include courses, programs and resources for athletes, coaches, parents, medical professionals and other target audiences as identified in the Code and ISE.
- Additionally, on ADEL, anti-doping practitioners can access learning opportunities such as training programs to help them carry out their roles through the GLDF; and a wide range of digital resources to support the development of their anti-doping programs through the CISP.

- The use of and access to ADEL is free with the objective of maximizing the reach of, and access to, quality education and learning opportunities to benefit all audiences, especially those working in or supporting the goal of clean sport. ADEL is for everyone, and anyone interested in learning more about anti-doping and protecting the values of clean sport. With internet connection, ADEL can be accessed at any time, from anywhere. The 'ADEL by WADA' mobile app is available on the Apple Store and Google Play store, enabling users to learn on the go and complete their education offline.

2.Executive Summary

The Anti-Doping Education and Learning (ADEL) platform has demonstrated significant growth and impact throughout 2025, reinforcing its position as a global digital education solution for the anti-doping community. With substantial increases in user engagement, enhanced support for Power Users, and data-driven improvements to course content and accessibility, ADEL continues to expand its reach across the global anti-doping community.

Key achievements in 2025 include strengthened Power User support through enhanced training materials and dedicated resources, integration of learner experience survey data to improve course navigation and content quality, and significant advancements in accessibility features. These improvements reflect ADEL's commitment to delivering high-quality, inclusive educational experiences that meet the diverse needs of stakeholders worldwide.

Looking ahead to 2026, ADEL will focus on updating existing content to the new 2027 World Anti-Doping Code and International Standards, continue the collaboration with Anti-Doping Organizations (ADOs) who are Power Users, and leveraging emerging technologies to further enhance the learning experience and searchability to anti-doping education. The strategic priorities outlined in this report provide a roadmap for continued innovation and impact in digital education and learning.

2.1 Highlights of 2025

- **Strengthened Power User support:**
 - Enhanced security through SSO migration and 2FA implementation (May 2025)
 - Comprehensive support program delivered: 2 webinars, 3 newsletters, 1 survey, and a Power User audit
 - New visual dashboard reporting functionality introduced
 - Ongoing support to maximize ADEL utilization for organizational education program
- **Multilingual access:** As ADEL education solutions have been designed and structured to correspond to each developmental stage along the athlete pathway, covering children and school sport to internationally competing athletes, there have been continuous efforts to support localization for ADOs that use ADEL as their main source of providing education.

- ADEL now hosts its largest number of translated courses to date, with 78 courses in 38 different languages published on ADEL in 2025. Seven new languages (Armenian, Bengali, Icelandic, Kazakh, Sinhala, Tetum, Turkmen) were added. A solution successfully implemented to ensure proper display of right-to-left languages such as Arabic and Farsi, strengthening multilingual learning across the platform.
- **Data-driven enhancement:** Comprehensive analysis of learner experience survey data led to improvements in new course development, especially with navigation, user interface design and accessibility advancements that improved learning outcomes.
- **Accessibility advancements:** Accessibility reviews were carried out and, in collaboration with the IPC and the International Blind Sport Association (IBSA), led to significant improvements including improved screen reader compatibility, keyboard navigation, and compliance with Web Content Accessibility Guidelines (WCAG), ensuring ADEL resources are available to all learners regardless of ability.
- **Platform growth and engagement:** Significant increases in active users, course completion, mobile app downloads with users from 239 countries and 235 sports, with a 1.65 million course completion demonstrating the platform's expanding reach.
- **Strengthened partnership with MEOs:** Deepened collaboration with supporting the pre-event education for IOC/ITA and IPC and promoting resources on ADEL for other MEOs.

- **Preparation for New Code 2027:** In preparation for the implementation of the revised 2027 Code and International Standards, the team has undertaken a comprehensive planning process to update all digital education and learning content. These updates will ensure that all educational materials remain accurate, relevant, and fully aligned with the new regulatory framework.

STRATEGIC PRIORITY 1: EDUCATION ANYTIME, ANYWHERE

We will provide a globally accessible learning platform that is open access, free and conforms to the required digital, accessibility and privacy standards

Strategic Priority 1: Education anytime, anywhere

1.1 – ADEL platform and app delivering an improved user experience

The ADEL platform and mobile app continued to deliver a modern, intuitive, and accessible interface, with monthly active users increasing by **12.7% in 2025**, resulting in total active users increasing by 33.7% reaching 594k. The athlete and coach populations have seen an increase of 36% and 29% respectively compared to 2025. Over **1.65 million courses were completed globally**, spanning **239 countries and 235 sports**.

1.2 – Courses and resources accessible offline

The ADEL by WADA mobile app **surpassed 66,500** downloads with a 30.9% increase from 2024 enabling offline access to courses and resources. Downloadable resources for youth and talented athletes in regions with limited internet access are also available to help facilitate offline education sessions and have been accessed 1,500 times after launch. These measures significantly broadened access to education in underserved areas.

1.3 – Accessibility review and WCAG 2.1 compliance

Accessibility reviews were carried out and, in collaboration with the IPC and the International Blind Sport Association (IBSA), led to significant improvements – resulting in the launch of the most accessible Milano-Cortina Paralympics course to date. WCAG 2.1 compliance remains ongoing for the platform, and accessibility guidelines have been factored into new course development.

1.4 – Privacy and security measures

Annual privacy audits were conducted, and the information security management system is maintained. To improve security, ADEL Power Users have migrated to a Single Sign On (SSO) platform and set up their Two-Factor Authentication (2FA) process at the end of May 2025.

1.5 – Terms of use and supplier agreement

Terms of use agreements remain in place, and the LMS supplier agreement will continue with Docebo through June 2027. This guarantees continuity of service and resource allocation. The agreement also supports ongoing enhancements to user experience and system stability.

1.6 – Policies and procedures

The ADEL Policies and Procedures document is regularly updated to reflect evolving practices. This ensures consistency in governance and transparency for all stakeholders. Privacy policy will be reviewed annually and updated in 2026.

1.7 – Resources for times of vulnerabilities

The **Guide to the 2026 Prohibited List** has been published in an interactive course format for the first time. This resource provides timely support for athletes and ASP to understand the new List before it comes into effect.

STRATEGIC PRIORITY 2: PLAYGROUND TO PODIUM – EDUCATION FOR EACH STAGE OF DEVELOPMENT

We will offer tailored education programs for different target groups that align with the Athlete Pathway Model.

2.1 – Review of clean sport behaviors and ASP curricula

This review is being done in parallel with the content updates for the 2027 Code and Standards. The aim is to better understand doping behaviors, policy impacts, and emerging issues. Insights will inform curriculum updates across athlete and ASP pathways.

2.2 – ADEL for Athletes

ADEL supports learning from playground to podium, following the athlete pathway. Education programs for international-level, national-level, talented, youth and children and school sport are available in various languages. Over 511K **athletes** are registered on ADEL and ILA has 267K completions. The Athlete Guide to the 2021 Code is the most translated content – available in 37 languages and has over 605K completions.

2.3 – ADEL for Coaches

ADEL for Coaches of High-Performance education program is available in **20 languages** and has over **64,000** completions. The Coaches of Recreational Athletes has been newly launched in 2025 and is available in English, French and Spanish.

2.4 – ADEL for Parents

ADEL for Parents of High-Performance Athletes education program is available in **4 languages** with over 1,700 completions.

2.5 – ADEL for Medical Professionals

There are 2 education programs available for medical professionals; ADEL for medical professionals and ADEL for Medical Professionals at Major Games (MPMG). There has been an update on the MPMG course

ahead of the Milano-Cortina Olympic Games, which is a prerequisite for team doctors attending the Olympic Games.

2.6 – ADEL for other roles

The **Sport Values in Every Classroom (SViEC)** is available for teachers along with the Sport Values online course, which has seen a 30K completion and is translated into Albanian and Slovak.

2.7 – Instructional design and quality assurance

Instructional design and quality assurance procedures are being respected during content development. An inventory log of athlete and ASP courses has been created to guide future updates in preparation for content updates for the 2027 Code and International Standards. A roadmap has been constantly updated to inform Power Users to plan for translations and preparation of relevant education programs to minimize duplication.

STRATEGIC PRIORITY 3: ENABLING ADOS – NO EXCUSES

There is no reason why athletes and/or athlete support personnel are not educated – we will empower and support ADOs to effectively deliver, enhance or increase the reach of their education programs to ensure that all athletes and athlete support personnel have access to quality education.

Strategic Priority 3: Enabling ADOs – No excuses

3.1 – Power User support

A validation of existing Power Users was performed in 2025, confirming a total of **205 ADOs**, including 145 NADOs, 57 IFs, and 3 MEOs. A comprehensive support plan has been developed to streamline workflows and improve platform utilization, including two webinars and three newsletters to support this initiative.

3.2 – Ready-to-use education programs

Robust education programs for different target groups were established and made available to ADOs. These programs allow ADOs to quickly deploy tailored education aligned with the athlete pathway. Downloadable resources further support offline delivery.

3.3 – Translation process and multilingual access

By 2025, **49 ADOs** engaged in translating resources, resulting in the highest amount of course publication in translated versions, **78 translated courses** across **38 languages**, including new languages Armenian, Bengali, Icelandic, Kazakh, Sinhala, Tetum, Turkmen. The ILA course is now available in **34 languages**, while the Athlete Guide to the Code is in **37 languages**. This expansion significantly increased global accessibility.

3.4 – Reporting structure

A new visual reporting dashboard is now available for Power Users (called Insights), enabling ADOs to monitor learner progress and generate reports in an intuitive way. This supports evaluation and compliance with the International Standard for Education. Power Users can actively use these tools to track outcomes.

3.5 – Identifying ADO needs

Consultations with ADOs identified needs for subdomains and customized content. Through the Power User Audit and survey, we have a deeper understanding of the usage of ADEL from ADOs and are reviewing granting enhanced Power User permissions.

3.6 – Downloadable resources

Downloadable resources covering testing procedures, supplements, and the Prohibited List were released in November 2024. These resources support face-to-face education sessions. They are particularly valuable in regions with limited internet access and have been accessed 1,500 times after launch.

3.7 – Recording learning experiences

The possibility of recording both digital and in-person learning experiences has been explored and confirmed that this is technically possible. However, this would be a future area of development as it would require power users to upload learning activities outside of ADEL. This functionality would allow for a more complete picture of athlete education and their journey.

STRATEGIC PRIORITY 4: BEYOND THE ATHLETE – ADO PRACTITIONERS

We will digitally support WADA’s capability program that aims to provide learning and development opportunities for anti-doping practitioners.

4.1 – GLDF training

MEO and Government Roles were newly added to the GLDF training program in 2025. A total of **225 practitioners** completed training across **15 programs**. This strengthens practitioner capability across multiple roles.

4.2 – Practitioner channels and communities

Practitioner channels and communities of learning remain active on ADEL. These spaces allow practitioners to connect, share best practices, and access resources. The IAPP and WADA have signed a two-year training agreement to have IAPP’s Foundation of Privacy and Data Protection course play a key role in training privacy ADO practitioners on ADEL.

4.3 – CISP resources

The CISP hub now hosts 353 resources, including factsheets, templates, and video tutorials. Resources are available in English, French, and Spanish. Updates of the content and platform CISP section are planned to align with the 2027 Code.

4D – Communities of learning

Communities of learning are being explored to further collaborate and to support ongoing professional development. They will remain a next step of practitioner engagement on ADEL. In line with this, a privacy newsletter was sent out to the privacy community.

STRATEGIC PRIORITY 5: MAXIMIZING DIGITAL EDUCATION AND LEARNING THROUGH COLLABORATION

We will collaborate with internal and external partners to benefit from the use of digital education and learning.

5A – Pre-Games education courses

Pre-Games courses for Milano-Cortina 2026 Winter Olympic and Winter Paralympic Games were published, with 17 languages and 10 languages available. Collaborations with IOC, IPC, and ITA ensured wide promotion.

5B – Engagement with MEOs

There has been a new collaboration with the International World Games Association (IWGA) and the Pan American Sports Organization (PASO) to encourage athletes and ASP in their respective events to be educated ahead of coming to their Games. MEOs actively promoted ADEL courses on their websites and social media. The Olympic Council of Asia (OCA) mandated TAME and CHP courses for the Asian Youth Games. These partnerships reinforce ADEL's role in pre-event education.

5C – WADA Learning Path

The WADA Learning Path has continued to be used for employee engagement and professional development. Annual training for Privacy, Security Awareness is available for staff to complete.

5D – Partnerships with external stakeholders

Partnerships were established to co-create topical education programs, including opioid abuse and image/performance-enhancing drugs. These collaborations expand the relevance of ADEL. They also diversify expertise and reach. The International Association of Privacy Professionals (IAPP)'s Foundation of Privacy and Data Protection courses have been offered to ADO practitioners via ADEL.

5E – ADO education plans

While ADOs have not yet shared summaries of education plans, this remains a priority. Improved communication through the ADEL roadmap will support this. Future efforts will focus on encouraging ADO participation.

5F – Creative use of digital technologies

WADA explored EdTech trends and AI tools to enhance clean sport education. Usage of an AI search feature on ADEL is being tested to enhance searchability for users on CISP. These innovations will be tested out with external stakeholders once the CISP 2027 is launched. In addition, the team is working on a proof of concept to make adaptive learning available for the updated ILA course in 2027.

5G – Demonstrating good practice

WADA continued to showcase good practice in digital learning by hosting webinars and publishing high-quality e-learning courses and promote the usage of different reporting functionalities on ADEL (visual dashboard).

STRATEGIC PRIORITY 6: DEMONSTRATING THE LEARNING IMPACT

We will capture and analyze data to gain deeper insight into the learning impact and effectiveness of our education and learning programs.

6A – Measurement strategy

ADEL's measurement strategy was strengthened in 2024 with a framework now in place to assess data collection across all programs. This includes tracking course completions, learner demographics, and assessment outcomes. The strategy ensures consistent monitoring and supports evidence-based decision making.

6B – Data informing content development

Learner data was systematically captured and analyzed to inform the 2025 content development plan. Also, Power BI was used to capture insights from the previous Paris 2024 Olympics and Paralympics courses to guide updates to publish an enhanced Milano 2026 Olympics and Paralympics course. This process ensures that new content directly addresses user needs.

6C – Monitoring and evaluation measures

Monitoring and evaluation measures derived from Social Science Research (SSR) were embedded into course design. These measures allow for ongoing assessment of knowledge retention and behavior change. Findings are shared with stakeholders to strengthen global education practices.

6D – Virtuous cycle of data

A virtuous cycle of data collection was initiated, linking learner feedback, SSR priorities, CCQ results. While partially implemented, an area of focus in 2026 will be improving how SSR priorities are linked and fed back into course design.

6E – Analysis of assessments and surveys

Final assessments and learner experience surveys were analyzed across all major courses. Results showed that over **86% of learners** responded that they are likely to apply what they have learned, and that 81% are confident in applying what they have learned. These insights are being used to refine instructional design.


6F – Practitioner feedback

Efforts began to solicit structured feedback from practitioners post GLDF training. This feedback loop will complement learner data and provide a broader perspective on program effectiveness.

4. ADEL - Statistics and Trends

4.1 User growth and engagement


- During the five-year period of 2021–2025, ADEL was used by close to **600K** users from 239 countries who participate in 235 different sports. 73% of users who have registered on ADEL are athletes, followed by coaches. The users have seen an increase in number in 4 aspects:



1. Overall platform user growth


Monthly active users averaged 19K, with a 12.7% increase compared to 2024.

There has been a 33.7% increase in the total active users on ADEL, 444K users to 594K users.



2. Geographic expansion


- The platform’s reach extended to 239 countries, with notable user growth in Argentina, India and Italy.
- In 2025, Argentina has doubled its user base to 14K users from 2024, followed by India growing 51% of its user base (15K). Mexico (89K) remains the top country with continuous increase of users, followed by Slovenia (74K).



3. Sport (IFs) engagement






4. Mobile app usage






- The most translated resource is the Athlete Guide to the 2021 Code, which is translated into **37** languages followed by the ILA translated into **34** languages.




4.4 Power Users
