Dear Mr. Howman,

Receive a sports greeting and my recognition for your valuable contribution to sport's development in the world.

The members of the American Sports Council (ASC-CADE) in the frame of the VII summit held on 15 February 2008 in Montevideo, Uruguay, unanimously agreed a new share out for the continental contributions to WADA. A copy of the signed agreement is enclosed.

The agreement keeps invariable the contributions equal to 50% and 25% of the continental total made by United States and Canada respectively. The remaining 25% is distributed among the other 40 countries, using the criteria of the Organization of American States - OAS. It was established a minimum percentage equal to 0.08% for the contributions of countries member of ASC-CADE but not OAS members.

The new formula will not only allow fulfilling with the contributions to WADA, but envisages a possible balance equal to approximately USD30000 in case the compliance on behalf all countries is achieved. The approved resolution proposes to WADA the reimbursement of the excess to ASC-CADE.

The above mentioned will require its formalization through and agreement between ASC-CADE and WADA, for which purpose we reaffirm our disposal.

This intergovernmental agreement is received with joy and makes evident our commitment for working jointly with WADA to fight the problem of doping in sports.

## **AGREEMENT**

*In the city of Montevideo, Uruguay on 15 February 2008, the countries member of the American Sports Council, unanimously agree:*

*That the responsibility of the contributions payment assigned to our continent by WADA-AMA will be shared out as follows:*

- a. United States will keep the payment of 50% and Canada 25% of the total amount assigned to the Americas as a whole.*
- b. The outstanding 25% will be distributed among the 40 remaining countries, applying the percentages of participation determined by OAS (Organization of American States) in its latest version, published in November 2007.*
- c. The OAS non member countries will contribute with a basic minimum equal to 0.08%.*
- d. To establish a formal agreement with WADA-AMA that guarantees the reimbursement of any excess.*
- e. The applicability of the adopted mechanism is four (4) years, that is, an Olympic cycle and will enter in force starting 2009.*

*With this document are enclosed the specific figures for each country with the formula duly applied.*
